PRIVACY STATEMENT

SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

When you use our mobile application (hereinafter “app”), we get access to the data provided by either Google (if using Android) or from Apple (if using iOS). When you browse our website, we also automatically receive your computer’s internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

When you use our app, we may also gather information about your phone, location and usage of the app.

When you purchase something directly from us, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address. If you purchase via Google or Apple we get the data needed to provide the services from them.

With your permission, we might send you emails about our app, website, products and other updates, in addition to new destination articles and marketing promotions.

SECTION 2 - CONSENT

How do you get my consent?

When you download our app you consent to us gathering information about your phone (model, make, operating system and other relevant technical specifications and information), location, usage of the app. When you register with us you consent to us gathering the information you register such as name provided, e-mail addresses and any other personal information required to complete a transaction or purchase. When registering we also gather additional usage data such as favorites, saved walks and tours for the purpose of being able to retrieve these for new devices.

If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

How do I withdraw my consent?

If after you opt-in, you change your mind, you may withdraw your consent for us to contact you, for the continued collection, use or disclosure of your information, at anytime, by contacting us at privacy@tripsteri.fi or mailing us at: [insert address]

SECTION 3 - DISCLOSURE

We may disclose your personal information if we are required by law to do so or if you violate our Terms of Service.

Terms of Service - Tripsteri App



SECTION 1 - INTRODUCTION

This website and mobile properties located at www.tripsteri.fi as well as related software applications (sometimes referred to as “apps”), data, SMS, APIs, email, chat and telephone correspondence, buttons, widgets and ads (hereinafter the “Services”) is operated by Tripsteri App Oy (hereinafter Tripsteri) . The Services are offered to you conditioned upon your acceptance of these terms of service (hereinafter Agreement). By accessing or using the Services, you agree to be bound by the Agreement and represent that you have read and understood its terms. If you do not accept all of the Agreement you are not authorized to use the Services. If you have a Tripsteri account and wish to terminate the Agreement, you can do so at any time by closing your account and no longer accessing or using the Services. Throughout the site, the terms “we”, “us” and “our” refer to Tripsteri while the term “you” “your” refer to either a Visitor or a Member.
